### 2. Detailed Progress Update

2.1 Please explain the key achievements under <u>each outcome with details of process</u> supported with key data points

Outcome 1: Outcome 1: 50 - 60% adivasi farmers (of 2715 farmers) in 82 villages will enhance productivity of 25 – 35% by cultural and natural farming methods in Cashew and Millets and will increase income of 20 - 35%.

Farmers from project villages are very interested and started Using Natural & organic fertilizers such as compost, manure, and cover crops to improve soil structure and nutrient values. It leads productivity also.

community started applying mulch to their crops for retaining soil moisture and suppress weeds. Drudgery also reduced by mulch with crop residues.

started Use of neem kernals and other kashayams, cow based bio inputs to manage pest infestations without harming the environment as well as quality of yield also improved.



Cultivating cover crops to protect the soil and enhance nutrient cycle and also utilizing rainwater harvesting and efficient usage of land resources.

Farmers are very much committed to saving seeds ensuing seasons for better yields and climate resilience.

Farmers are accessed the agriculture inputs/tools for reducing their hardness in their labour work.

Outcome 2: Improved inclusion (up to 80%) of Adivasis under various schemes and entitlements through training a cadre of 162 youth in 82 villages and by coordinating with 18 village secretariats and Seetampeta ITDA

Representations from all the villages to concerned department raised & members got their MGNREGS job cards & availing woks in the area also drinking water issues solved with house tap connections accessed.

People accessing education, health &other essential services is increased in the project villages regular health checkups & monitoring is very much evident in the area.

Got sanctioned House pattas (Housing schemes got utilized) & Land Pattas in these villages & other eligible submitted their representations to officials.

Increased in accessing of social welfare schemes like pensions in the villages

Nearly 50% villages schools teachers regularity(attendance) increased

Village level youth participation improved in the village level problems solving

Gramasabha's meetings people participation increased up to 40%

Increased collaboration between PRI members and Sachivalayam (Department)

Seek traditional knowledge of old farmers and elders supports for mobilizing other farmers towards Tradination & Natural farming practices.

RYSS programme initiatives are encouraging in our operational area. Horticulture department has been supporting to farmers by their productivity enhancement programmes in our operational area.

Farmers are showing their enthusiasm to take up Natural Farming practices.

Government social welfare schemes, Health and Education are very much helpful and speed up mobilization of beneficiaries in the area.

Maintained Good rapport with Panchyat Sarpenches/Sachivalaya staff and Mandal level officers and also ITDA officers.



Convergence with all line departments, Sachivalaya and Mandal level interface meetings also very helpful to solve the problems immediately

2.3 What were the challenges faced and learnings during the implementation of the programme?

Remote locations - Most of the fields are situated around and top of the hills. They should spend more time to take up planned activities timely. All the farmers to seeking support physically, but with our limited resource, could extend to few farmers directly.

We planned to involve all the farmers to select and develop the models at their respective villages. Trainings and other technical support would provide to all the beneficiaries to get more yield and increase income levels.

Information Gap: lack of awareness on schemes, complication in process/not aware of accessing it. We mobilized and capacitated the youth how to access the programmes through sachivalayam.

80% villages No meeting halls/community buildings so meetings organized big challenge
